The dimension of the arrays that holds the sum of monthly statistics by year was increased from 20 to 99.

ISSUE: WO Costing Change Has Bad Accounts for Recreated JV

Symptoms:

The WO costing change reversed the original transaction lines for the 2 JV's (4 lines) just fine. However, when it recreated them for the new costing, the first JV was fine but the 2nd JV that had 3 lines with different accounts was recreated using the same account for all 3 lines.

Resolution:

The code was getting all lines on the JV that referenced the WO but only using the first record's account no matter which line was being processed. It was changed to get the transaction line info for the specific line it was processing so only 1 record was returned.

Added column enteredbyid to the po header table. The status screen displays the entered by person. When a PO is reversioned the entered by person id remains the same. When a PO is copied the entered by person id becomes the id of the person copying the PO.

ISSUE: Asset Disposal Report Displaying Incorrect Amounts

Symptoms:

The Asset Disposal Report always displays the accumulated depreciation as an amount equal to the asset cost even though this is not always the case.

Resolution:

The report now shows the depreciation accumulated at the time of the disposal by summing the depreciation amount up to but not including the disposal journal entry. Net book value of the disposed asset is calculated using the formula Asset Cost - Accumulated Depreciation - Proceeds From Disposal + Gain(Loss) which should always be zero for a disposed asset.

ISSUE: Buttons Don't Enable After You Add A New JV

Symptoms:

After adding new JV, many of the toolbar buttons such as Open, Post and Print should be enabled yet they are not. The workaround is to click onto another JV then back onto the one just added or hit the Find button again then locate the new JV in the tree.

Additionally, opening an existing line and clicking Save presents a message asking if you want to save your changes even though you just did. The screen is then reloaded with blanks.

Resolution:

Once a new Journal Entry is added, it appears in the tree however, the highlight of the item is removed, causing the buttons to be disabled. The item will now remain selected.

Secondly, the order of resetting the PO reference field was switched so that the routine did not think the current change was being made by some other user.

Symptoms:

After reorganizing the structure of equipment in the equipment tree, going in to the scheduling application to regenerate the list of tasks takes several hours. There needs to be a setting to limit the how long closed tasks appear on the schedule before being dropped.

Resolution:

A new covalue entry SCHEDULETASKCUTOFFINTERVAL has been added to the system. This covalue entry contains the number of days to include closed work order tasks on a schedule when the schedule is added or changed and rebuilt. For example, if the covalue entry is set to 365 all tasks closed within the last year will be included on the schedule. The covalue entry defaults to 365 days and can be changed on the site-specific Options window found in the Options menu in Scheduling.

Resolution:

Calculating the current value will not include previously added in line amounts.

ISSUE: PO Delete Only Removes Lines with The Same Version as Header

Symptoms:

If you delete an entire PO, the delete code deletes lines, cost, ship and line shipping records with the same version number as the header.

For the PO lines, either delete all lines or flag latest version of each line as deleted. Cost, ship and line shipping do not have a status field so they will have to be deleted or left as is.

When a PO is deleted it is not removed from the lookup list.

Resolution:

When deleting a purchase order then delete all lines, costing, shipping and line shipping records.

Also delete text records except for the header text.

Delete custom entries.

Once a PO has transactions then lines can no longer be physically deleted, they will be flagged with a deleted status.

Once a PO has transactions (for example, issued) it must be cancelled instead of deleted.

When a PO is deleted remove the PO from the lookup if the PO was in the list.

ENHANCEMENT: Depreciation of Fixed Assets with Negative NBV

Currently the Fixed Asset application does not create depreciation against an asset with NBV that is negative. This enhancement will allow depreciation journal entry lines to be created for assets with a negative NBV.

Solution:

It is now possible to enter an asset or asset addition with a negative cost. When the monthly depreciation journal entry is created depreciation will be created with opposite dr/cr indicators when the value of the asset is negative.

A purchase requisition was sent back to In Entry. The costing was changed which caused the approving department to change. In this case the workflow code automatically set the next step to be the first approval step, skipping the buyer review steps.

Resolution:

When loading the Expected Steps tab, if the approving department has changed then we want the next step to be the first approval step (to make the document go through approvals again).

If the document is currently before the first approval step then leave it there.

If there are no approval steps send it back to the first step.

ISSUE: Deleting PR Line Should Delete Bid Lines Also

Symptoms:

When deleting purchase requisition lines from the Bids application lines grid after bids/awards have been entered does not delete the bids from the prprice table. The undeleted records may cause problems for the bid later.

Resolution:

When deleting lines from lines grid in the Bids application the bids in the prprice record for the line being deleted are also deleted.
